**Deposit:** A minimum down payment of 75% the list (full) price is required in addition to any extra charges that may apply.

We are not responsible for any changes in fitting measurement after the order is placed with us.
**Dye Lot variation:** There might be a dye lot variation as noted on all designers' color swatches.
**Cancellation:** All sales are final and there will be no cancellation, refund, credit, or exchange unless seller is unable to obtain the merchandise through no fault of its own or default of contract by manufacturer. The deposit in connection with this purchase is neither refundable nor transferrable. This policy applies to special orders, incomplete orders, & off rack purchases.
**Wear Date:** The merchandise is ordered for the wedding/wear date noted on the contract. If that date moved forward, we will do everything possible to deliver earlier, but can not guarantee as we have no control over manufacturer's schedule.
**Ship Date:** All ship dates are approximate and the manufacturers may change that date based on their schedule.
**Shipping:** All orders are shipped to Fantasia by standard UPS or Fed Ex free of charge.
If desired, we can ship the dress to your address at additional charge (\$25/dress in the continental Unites States).
**Order Arrival & pick up:** For better communication, we notify the Bride in writing and she notifies her bridal party. Please inspect and pick up merchandise within 15 days of arrival. Any items not picked up by the wedding date will be considered abandoned and will be donated to local charities.
